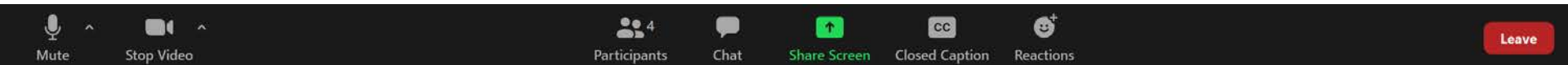

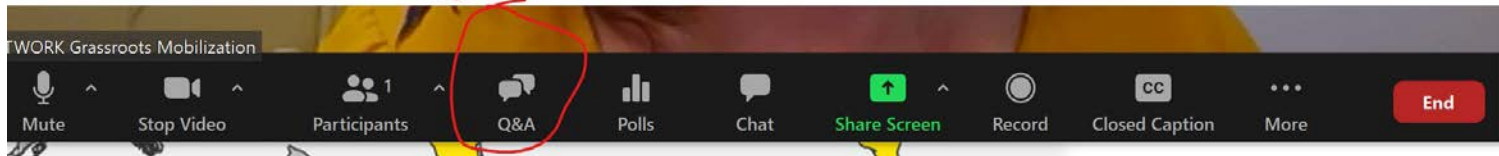

 - ☀️ U.S. Citizenship Act - House and Senate
 - ☀️ Citizenship for Essential Workers - Senate, soon in the House
 - ☀️ Dream Act - Senate
 - ☀️ SECURE Act – Senate
 - ☀️ Dream and Promise Act - House
 - ☀️ Farm Workforce Modernization Act - House



Legislation: Where We Are







Pathway to Citizenship

- ☀️ U.S. Citizenship Act - **11 million undocumented immigrants**
- ☀️ Citizenship for Essential Workers - **5.2 million**
- ☀️ Dreamers and TPS legislation - **4 million**
- ☀️ Farm Workforce Modernization Act - **1 million undocumented farmworkers**








Legislation: Where we are Going

House

-  Dream and Promise Act – to be passed Thursday
-  Farm Workforce Modernization Act – to be passed Thursday
-  U.S Citizenship Act – Hearings April/May
-  Citizenship for Essential Workers - yet to be introduced

Senate

-  Dream Act – possible hearing in April/May - bipartisan
-  SECURE Act
-  Citizenship for Essential Workers
-  Farm Workforce Modernization Act – yet to be introduced
-  U.S. Citizenship Act



Administrative Wins



- ☀️ TPS for Venezuelans
- ☀️ Public Charge Rule blocked.
- ☀️ No sharing of information between ICE and Health and Human Services.
- ☀️ Processing people who were in MPP.

Border issues



- ☀ **Unaccompanied Children**
- ☀ Shelters
- ☀ Reunification



Border issues



- ☀️ **Title 42 Order**
- ☀️ It is a public health order that doctors and public health officials have condoned in this particular application.
- ☀️ The New Wall.
- ☀️ Effects Black and Haitian Migrants disproportionately.



What can we do?

- ☀️ Understand and remind ourselves and our neighbors that there is no crisis because of children at the border
- ☀️ Ask Biden to rescind the Title 42 order
- ☀️ Call your Representative ask them to vote for the House bills H.R 6 and H.R 1603 tomorrow
- ☀️ Call all your members of Congress to support U.S. Citizenship Act and and Citizenship for Essential Workers Act
