What's Happened Since January 20: Trump Administration's Chaos & Conflict

- President Trump promised "shock and awe"
- What we see: Project 2025 developed by the Heritage Foundation
- **Trump administration's executive actions** have attacked ALL areas of NETWORK's "Economy for All" agenda:
 - Jobs with paid leave and living wages
 - Affordable housing, food, and health care
 - Safe and welcoming neighborhoods
 - Clean air and water
 - A tax code that ensures the wealthy pay their fair share
 - A just and humane immigration system
 - A politics responsive to the people, not the money



Elon Musk: Billionaire Calling the Shots

- **Department of Government Efficiency (DOGE):** New advisory body created by President Trump under Executive Order
- Stated mission: "Save taxpayers' money and reduce U.S. national debt"
- What are they really doing? Going into agencies they disagree with; indiscriminately slashing budgets and firing personnel; gaining access to our nation's most sensitive data
 - \circ No transparency
 - Spreading misinformation about government spending
 - Musk has significant conflicts of interest given the billions in contracts his businesses hold with the U.S. government



NETWORK Responds with "Truth and Light"

Telling the truth

- Track it: Tracking all executive action that impacts NETWORK's agenda
- Use our voice: Speak up and speak out
- Inform: Providing resources to our field

Taking action

- The courts are key: Reaching out to key litigation leaders to see how NETWORK can partner (ex. NETWORK recently signed an amicus brief in support of the Affordable Care Act)

Refresher on Budget Reconciliation

NETWORK's Goal: Mitigate damage to our communities

- Reconciliation is a tool—a special process—that makes legislation easier to pass in the Senate
 - Created in 1974 by the Congressional Budget Act to make it easier for Congress to alter revenue and spending to align with the annual budget resolution
 - Process used when a single party holds power over the White House, Senate, and the House of Representatives
- How is reconciliation different from a regular bill?
 - Instead of 60 votes, a reconciliation bill only needs a simple majority in the Senate and cannot be filibustered
 - Only policies that change spending or revenue can be included

THE ROAD TO Reconciliation

CONGRESS PASSES A BUDGET RESOLUTION

This resolution instructs specific House and Senate committees to write parts of the reconciliation bill and tells each committee how much to change spending or revenue.

COMMITTEES WRITE RECONCILIATION BILLS

The instructions in the budget resolution dictate which committees can contribute to the reconciliation effort and what the committees may produce.

COMMITTEES MARK UP THEIR BILLS

At this point, committee members may offer amendments modifying i.e., "marking up"—the legislation.

THE COMMITTEES' BILLS ARE COMBINED Into a single reconciliation package

That bill can now come before the House and Senate for a vote—but their processes for reaching that vote are quite different.

DIFFERENCES BETWEEN THE HOUSE AND SENATE BILLS ARE RECONCILED

The House and Senate must approve the same version of the reconciliation bill.

THE PRESIDENT SIGNS THE BILL INTO LAW

Once the House and Senate pass the same version of the reconciliation bill, the final bill goes to the President to sign into law or veto, just like any other bill.





Our Superpower: Politics = Math!



Tax Policy

Vital social safety net programs face significant cuts to pay for renewed tax breaks for the ultra-wealthy.

- Passed by Republicans in 2017, the Tax Cuts and Jobs Act (TCJA) gave massive tax breaks to billionaires and corporations
- The TCJA will expire at the end of this year
- As part of the Budget Reconciliation process, House Republicans have proposed \$4.5 trillion in tax breaks for the wealthiest Americans
- Private equity, inequality in wealth, and wealth concentration will find favor in all the wrong ways
- To pay for these tax breaks, they are looking to decrease spending by \$2 trillion or more gutting our food programs, health care, housing, education, clean energy, and more
- Corporations boosted their bottom line on the backs of working and middle-class people and families



Detention and Deportation




In a recent letter to the U.S. Bishops, Pope Francis wrote,

"... the act of deporting people who in many cases have left their own land for reasons of extreme poverty, insecurity, exploitation, persecution or serious deterioration of the environment, damages the dignity of many men and women, and of entire families, and places them in a state of particular vulnerability and defenselessness."

Detention and Deportation

- **Proposed cuts to social safety net programs** will help pay for expanded detention and increased deportations
- At least \$300 billion has been allocated for detention and deportation
- 90% of all people held in immigration detention are held in facilities run by **private corporations**
 - In 2022, Geo Group made \$1.05 billion in revenue from ICE contracts alone
 - CoreCivic made \$552.2 million in revenue from ICE detention contracts
- Reconciliation bill proposes doubling the number of detention centers from 2022
- Military deportation flights cost as much as \$3 million per flight
- Spending exorbitant amounts on transferring and jailing immigrants in Guantanamo



Protecting SNAP

The Supplemental Nutrition Assistance Program (SNAP)

- For decades, SNAP has served as our nation's most essential tool to prevent hunger
- SNAP is also central to lifting people out of poverty
- Even with SNAP, **34 million** people in the U.S. still face hunger, including 9 million children
 - This is immoral!

House Budget Committee Proposal

- Significant cuts to SNAP
- House Committee covering anti-hunger programs (including SNAP) will have to cut \$230 billion
- Some proposals would reduce benefits for all 40 million SNAP beneficiaries (ex. \$6.20 decreased to \$4.80 per person per day)
- Other proposals would drop people from SNAP entirely with the addition of harsh new work-reporting requirements

Protecting SNAP



The Challenge

Congress must hold the line against any cuts to current SNAP benefit levels and against any new and more punishing work-reporting requirements.

The Opportunity

Congress must remove the Farm Bill's unjustifiable lifetime ban on SNAP benefits for individuals convicted of drug felonies.

Medicaid Cuts: Slashing Federal Payments

- \$1.3 trillion
- Ending ACA matching of 90% for those who enrolled when Medicaid coverage was expanded
- Eliminating the 50% floor for federal matching funds
- Eliminating higher federal matching % for Washington, D.C.


- Medicaid Expansion enrollment: 20,606,401
- Current cost to states: \$14.9 billion
- New cost to states without 90% match: \$64.9 billion
- Increase in costs for the 11 states with the lowest matching % if floor is removed: \$42.9 billion

Medicaid Cuts: Ending Medicaid as an Entitlement

- \$918 billion
- Imposing "per capita" caps, which would set the allowable increase in costs at below the expected rate
- Could be set at a uniform rate over time

Total Medicaid Cuts From a Per Capita Cap Would Grow Over Time




Medicaid Cuts: Imposing Work-Reporting Requirements

- \$120 billion
- 67% of those with Medicaid are children, people with disabilities, or seniors
- Imposing work-reporting requirements would not meaningfully increase the number of Medicaid beneficiaries with jobs (Congressional Budget Office)
- Instead: Creates bureaucratic hurdles to staying enrolled

People in Every State Could Be at Risk of Losing Medicaid Coverage

Affordable Care Act Cuts

- \$151 billion
- Forcing states to end coverage for non-US citizens
- Would save \$15 billion by threatening the immigration status of those who use public health insurance
- Requiring beneficiaries to pay back premium credits if their income has gone up within the year
- Reducing or ending premium tax credits, jacking up the cost and causing 4 million people to become uninsured
